The UN Trust Fund in support of Peace and Security in Mali was created at the request of the Security Council (SC resolution 2085 (2012)).

Since its creation, the Trust Fund in Support of Peace and Security in Mali:

- provides vital support to the Malian Defense and Security Forces (MDSF),
- assists the Malian Government in its efforts to ensure lasting peace and the return of State Authority and constitutional order and
- supports critical interventions contributing to the immediate and long-term efforts by the international community to resolve the crisis in Mali.

It is supported by **voluntary contributions** from the following donors: Australia, Austria, Belgium, Canada, Denmark, Germany, Ireland, Italy, Luxembourg, the Netherlands, Norway, Switzerland, Sweden, Turkey, the United Kingdom and UN DOCO.

Since 2013 and to date, the Trust Fund amounted to over **118 Million US**, of which over **102 Million US** dollars had been allocated to some **329 projects** (234 completed, 82 ongoing and 13 planned).

SUPPORT TO THE PEACE PROCESS

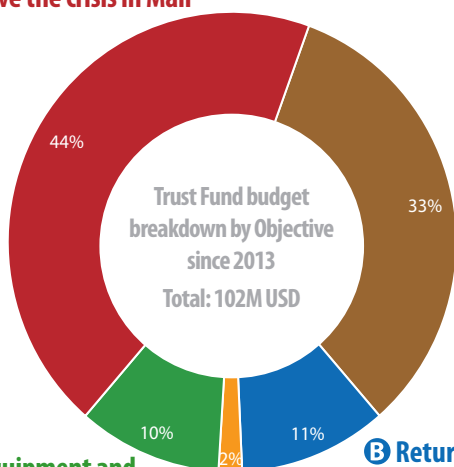
The Trust Fund provided essential support in the frame of the peace process, allowing inclusive negotiations and the effective implementation of interim dispositions foreseen in the Agreement for Peace and Reconciliation in Mali in the areas of **Mediation, Reconciliation, SSR/DDR, Security, Restoration of State Authority** and **Rule of Law**.

PEACE DIVIDENDS

The Trust Fund made possible interventions addressing urgent needs of populations in the north of Mali in terms of basic social services. These improvements in the daily life of people are aimed to strengthen popular support for the peace process, whilst addressing urgent community needs in the areas of **Large Infrastructure, Water and Sanitation, Energy** and **Economic Recovery**.

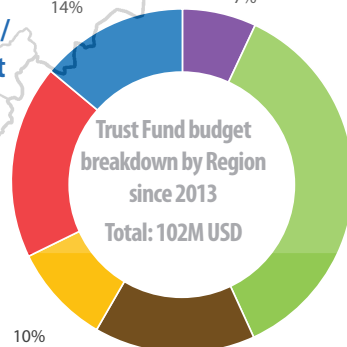
