Donor Coordination and Partnerships

1. On January 21st, was held a CRZPC meeting (*Commission Rehabilitation des Zones Post-Conflict*) with a select committee made of France, MINUSMA and representatives of the MAHSRN.

Main objective was for the Ministry to present the implementation status of the regional Emergency Plans from July to December 2015. Participants suggested to summarize covered sectors and areas of interventions, while highlighting financing gaps to be filled and donors' contributions. Other recommendations were to communicate more on the achievements of the regional Emergency Plans and perspectives for 2016 with signatory groups. The next CRZPC political meeting is planned for beginning of February.

2. S&R attended the United Nations Country Team (UNCT) retreat organized in Bamako on 20th and 22nd of January and chaired by Mrs. Mbaranga GASARABWE, MINUSMA Deputy Special Representative of the Secretary-General, UNDP Resident Coordinator and Humanitarian Coordinator (DSRSG/RC/HC). Attending agencies included UNDP, FAO, UNIDO, UNESCO, UNOPS, IOM, WHO, UNMAS, OCHA, UNHCR, WFP, UNWOMEN and UNAIDS while all sections' Heads of the DSRSG/RC/HC Pillar represented MINUSMA. The objectives of the retreat were to have a common understanding of integration between agencies and the Mission and to identify concrete entry-points for collaboration, in order to foster the "Delivering as One" approach in Mali. Other high-level attendees included the Special Representative of the

Trust Fund in support for Peace and Security in Mali

1. The S&R Director ad interim and the Trust Fund Manager visited Mopti on 19th and 20th of January. During this mission, the Mopti Humanitarian Regional Team (HRT - comprised of humanitarian actors and UN agencies) was briefed on the Trust Fund and invited to submit project proposals, in particular for community impact projects. The HRT showed great interest in doing so.

Areas of collaboration and partnerships between

all UN partners were discussed. Meetings were also held with different MINUSMA components and executives based in Mopti including the Head of Regional Office, the Civil Affairs Division, the Human Rights Division and the UN Police (UNPOL). These discussions came to the conclusion that the Trust Fund could bring important peace dividends in support of regional authorities and communities of Mopti.

Gao

1. On 14th of January, **official reception of newly rehabilitated and equipped Centre NIALI** took place in Gao in presence of the visiting delegation lead by the DSRSG/RC/HC, Gao's Governor, the Director of the National Solidarity Fund, traditional notabilities and local population. The *Centre NIALI* takes care of vulnerable children and women but stopped its activities due to destruction of its assets during the occupation by Jihadists. Thanks to this QIP sponsored by MINUSMA Civil Affairs Division and representing approximately 40,000 USD, 220 children and 80 women can now be taken care of, benefit from new equipment and rehabilitated rooms and access to income generating activities developed through the *Centre*.

2. On 26th of January, in the context of cooperation with UN agencies, **a ceremony was held for a QIP providing food assistance to 624 persons living with HIV at the premises of the Haut Conseil de Lutte contre le Sida (HCLS)**, with beneficiaries, MINUSMA-S&R and partners including UNAIDS.

3. Last November, **MINUSMA reequipped the multi-ethnic regional orchestra Songhoy Star with new music instruments**. During the music ban in northern Mali, all instruments were destroyed and musicians like Songhoy Star members were forbidden to play. The *Direction Régionale de la Culture de Gao* and MINUSMA Environment and Culture Unit were involved in this journey from silence to sound. **Watch the documentary** (in French):

Kidal

1. On 5th of January, **local population and authorities of Inhalide (Tessalit Cercle in Kidal region) participated at the handover of a 60Kvas generator aimed at electricity supply and water pumping**. Representing a budget above 35,000 USD, this QIP is implemented by ASSAHSSAL NGO and sponsored by MINUSMA Civil Affairs Division. The project involved the local management committee, youth and women associations as well as traditional community leaders. The handover was combined with a training of the committee and supply of 1,900 liters of fuel. The village chief, the president of civil society and the women representative commended MINUSMA for this crucial water initiative, which supports 5,000 direct beneficiaries and will boost productive sectors such as livestock and food crop production.

2. On 15th of January, **S&R facilitated the visit in Kidal of a delegation lead by the Deputy Special Representative of the Secretary-General from Bamako**. On this occasion, the DSRSG/RC/HC held a series of meetings with: (1) MINUSMA military and substantive sections' staff regarding challenges related to projects implemented by the Mission, security and cantonment in the Kidal region, (2) women associations, to take stock of their priorities and needs, (3) international NGOs on humanitarian access, (4) CMA and Civil Society on peace and social cohesion challenges, cantonment and the *Comité de Suivi de l'Accord (CSA)* meeting organized in Algiers on 18th-19th of January. Mrs. Mbaranga GASARABWE also seized the opportunity of her mission to visit the *Centre de Santé de Référence* in Kidal City, now running with a reinforced electricity network and operating in improved conditions for the benefit of both the medical teams and patients.

3. On 22nd of January, **in Anefis, the QIP for electrification of the town has been officially handed over** in the presence of MINUSMA represented by the Civil-Military Coordination (CIMIC) team and the Community Liaison Assistant (CLA) based there, local authorities, the management committee and the population. Amounting above 41,000 USD and sponsored by CIMIC, the project includes the purchase, transport and installation of an 88Kvas generator and streetlights, the donation of 2,000 liters of fuel and capacity-building for the management committee, benefitting to the 2,000 permanent residents of Anefis.

On the same day, **CIMIC Officer and CLA took stock on the QIP in support to the production of traditional leather tents for the benefit of displaced women of Anefis**, where 40 women beneficiaries back to their local town exposed them the 10 already produced tents out of a total of 80. They've been brought together and trained through this 40,000 USD project sponsored by MINUSMA Kidal Regional Office and generating an important source of income.

Peacebuilding Fund (PBF)

1. In close collaboration with agencies implementing projects and their partners, S&R's PBF team and Monitoring & Evaluation Unit and the AE2C consultancy in charge of the monitoring and evaluation of the PBF programme organized and lead **visits of PBF projects' realizations respectively in Gao (18th of January 2016) and Timbuktu (20th of January 2016)**. This mission comes within an overall exchange process regarding PBF projects in view of a thorough assessment of the quality of interventions with regards to local populations, main beneficiaries in the field.

2. **UNDP and UNIDO** jointly lead a project in "support to capacity-building in conflict resilience for women and youth in Gao and Timbuktu regions". In this context, **opened the « Centre d'Ecoute d'Information, de Documentation et d'Education à la Paix et à la Réconciliation de Gao » for youth representing various associations focused on peace and local development**. Trained youth organized awareness-raising activities there on social cohesion, citizenship and *causeries* in the local « grins » (informal fora of discussion) and public spaces in view of setting the ground for peaceful coexistence between communities. To date, 150 sessions were held.

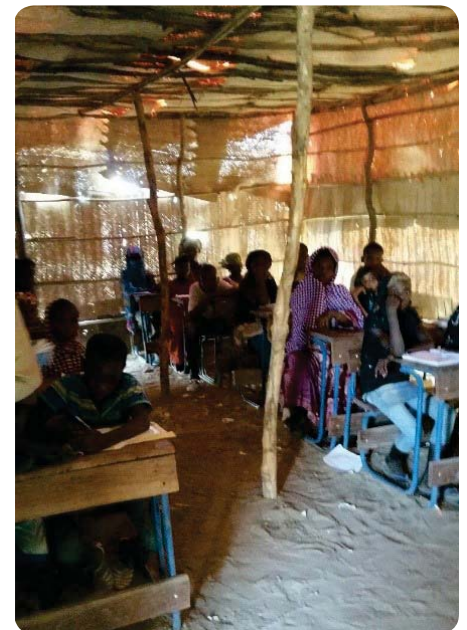
During the PBF partners' visit, 20 young women and men insisted on the importance of the *Centre* and their mission to promote dialogue and reconciliation. Abdou, a young man who attended the training on dialogue and conflict resolution, explains that local thieves robbed his motorcycle and his friends wanted to do him justice planning a punitive expedition. Using his training, Abdou was able to manage this calmly, reasoned his friends and sensitize them on dialogue to make the offenders understand they are all brothers in the same little town.

3. **IOM and UNHCR** collaborate on the project "Solutions for a sustainable and peaceful reintegration of internally displaced people (IDPs) and repatriated refugees in Gao and Timbuktu regions". **Income Generating Activities are planned and a selection committee of beneficiaries has been established** comprising neighborhood leaders, members of women associations and organizations of displaced and repatriated people. Selection criteria are based on vulnerability assessment of each beneficiary, identity check and clearance of commission's decisions by community stakeholders. 4 neighborhoods are targeted in Gao, with 25 beneficiaries each (100 in total): Aldianabangou, Sossokoira, Gadeye et Château. PBF partners could meet several persons supported in this context like Fadimata, 37 with a physical handicap, head of household and unemployed. The assistance she received allowed her to open a small commerce and hire a family member for management: "This activity changed my life which was plagued by precariousness due to handicap. It allowed me to meet family expenses and support my 15-year-old daughter studying in Gao high school. It also gave me hope for a life with income." ▼

4. **UNICEF PBF project on "education for peace consolidation in the north of Mali" allowed to open 150 Centres d'éducation accélérée et passerelle (SSA/P – speed school strategy) in Gao and Timbuktu regions in October 2015**. These centers receive 4,500 children, including 1,717 not attending and out-of-school girls all school year long. 150 activity leaders (women and men) were trained and will be teaching. The SSA/P of Gao Château opened prior to school reopening mid-October and communities took ownership of the project facilitating a place to accommodate it. The mission had the opportunity to meet with members of the center management committee, the neighborhood leaders and his 16 counsellors including 7 women, the village committee and representatives of locally elected officials. The latter recognized the importance of this center and the change in the lives of children and their families, thanks to their constant presence. In reality, the center is an opportunity for meeting and discussion for all ethnic groups. Nonetheless, they see considerable challenges ahead, like solid construction against bad weather, the need of a canteen to maintain children at school and better educational monitoring. Gao Academy is going to take measures in this matter. ▼

Peacebuilding Fund (PBF)

5. UN Women, UNFPA, MINUSMA join forces on a project relevant to the PBF Gender Promotion Initiative “for a better access to justice and security for women victims of SGBV in the peacebuilding process in Mali”.

In Timbuktu, the visiting team went to the women community center, which opened in January 2016 and where training is provided to women in view of income generating activities, as well as literacy classes, film screenings and debates. 4 activity leaders supervise the students from Monday to Friday, with a specific programme displayed each week for public information. Thanks to the PBF project, the center received equipment such as motorcycles, furniture and IT appliances and welcomes NGOs like International Medical Corps to facilitate trainings on gender based violence (GBV) among other topics. Women met onsite see the center as an open space for dialog cementing social cohesion and a place to “open the eyes” violence towards women. ▼

The mission also discussed with the women leaders of *cases de paix* in Timbuktu, the « *Cases de femmes* » group comprised of women members of various associations which benefitted from the support of the GPI project through a training in transitional justice, the role of the Truth, Justice and Reconciliation Commission and public speaking techniques. These women reckoned this made them understand the concept of transitional justice in the reality of the Malian crisis and realized their role for the conflict impact on women to be taken into consideration within this recovery process. They are now in contact with human rights organizations and provide assistance to GBV victims in court.

In Bamako, on 26th of January 2016, also within this joint UN Women, UNFPA, MINUSMA in collaboration with civil society, **nearly 60 Malian députés and legislative officials from the *Assemblée Nationale de la République* participated at an awareness-raising workshop on the adoption of a law against violence and discrimination towards women.** Participants committed to sensitize their peers to reinforce the fight for the adoption of the aforementioned law. During the same week, **the GPI project also funded the organization of an open day on 1325 Security Council Resolution.** This was an opportunity for representatives of women and youth associations to exchange views directly with UN high representatives on the implementation of this Resolution in Mali, and their involvement in the peace process in particular. 6. Further to the no-cost extension accepted by the Peace-Building Support (PBSO) for the funding of UNOPS PBF project, **construction of 3 cantonment sites commenced in Likkarakar (Timbuktu region), and Fafa and Innegar (Gao region),** employing 90 local youths and ensuring them temporary income.

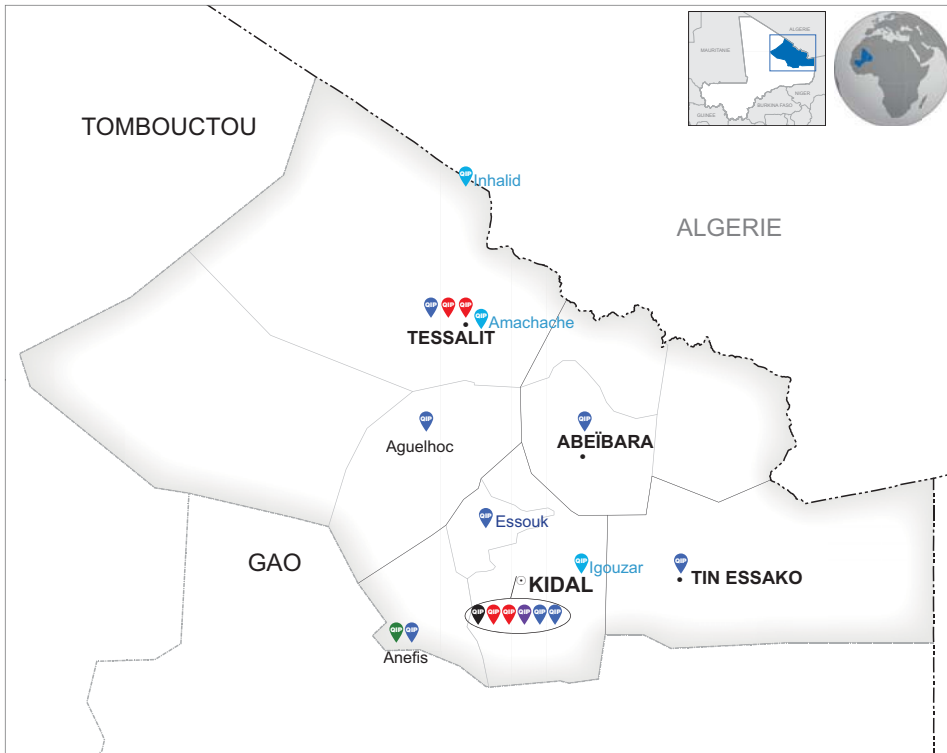
Financed by MINUSMA, Quick Impact Projects (QIPs) are community micro projects. These projects have a maximum cost of 50,000 USD and a maximum 6-months duration, in the areas of services and small public infrastructures rehabilitation, training and awareness-raising activities, employment and revenue creation. They must have both a quick and long lasting

effect meeting priority needs of the population and aim at building confidence towards the peace process, the Mission and its mandate.

Between 1st of July 2015 until 30th of June 2016, a 4 million USD budget will be dedicated to approximately 114 QIPs.

These projects will benefit mainly northern regions and will support requests from the Malian Government, international and national NGOs, international agencies and civil society. All projects are executed through local partners and businesses.

The UN Trust Fund in support of Peace and Security in Mali was created at the request of the Security Council (SC resolution 2085 (2012)). Member States can contribute earmarked and/or non-earmarked funds to the Fund, which aims to provide vital support to the Malian Defence and Security Forces (MDSF), assist the Malian Government in its efforts to ensure lasting peace and the return of State Authority and constitutional order, and support critical development and humanitarian interventions contributing to the immediate and long-term efforts by the international community to resolve the crisis in Mali.

It is supported by voluntary contributions from the following donors: Australia, Canada, Denmark, Germany, Ireland, Luxembourg, the Netherlands, Switzerland, the United Kingdom and UN DOCO. The Fund's budget currently amounts to approximately 19.6 million USD, of which some 67 per cent has been attributed to projects.

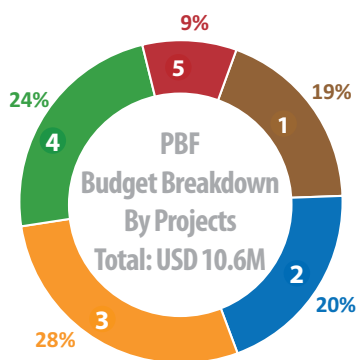

To deal with the political, institutional and security crisis that deeply destabilized Mali since 2012, the Malian Government and the United Nations System in Mali resorted to the Peacebuilding Fund (PBF) in order to support peacebuilding and reconciliation. The Government of Mali submitted an eligibility request to the Peacebuilding Support Office (PBSO) on 24th of February 2014 which was approved by Secretary-General of the United Nations on 2nd of April 2014.

In this context, the intervention of the PBF programme in Mali represents in its first phase 10.9 million USD, of which 10.6 have been attributed to 5 projects undertaken by UN agencies and MINUSMA. A Steering Committee oversees the whole programme and gathers the Malian Government, the civil society, international donors and the United Nations. The remaining 0.3 million USD goes to the Steering Committee Support Office.
