## Donor Coordination and Partnerships

**1.** On 5<sup>th</sup> of May, a **technical committee of the CRZPC took place, extended to international NGOs represented by the FONGIM**. The following topics were discussed: (1) finalization of the mapping of development interventions in the northern regions of Mali, (2) the upcoming workshop on methods of intervention and coordination of actions in post conflict areas, (3) follow-up of the CSA work, particularly the Development Subcommittee's, on finalizing various strategic documents and on important issues (specific development strategy for the northern regions, the humanitarian emergency plan, Terms of Reference of the *Fonds de Développement Durable*, operationalization of the *Agences de Développement Régional*).

**3.** On 30<sup>th</sup> of May, a **political meeting of the Commission Réhabilitation des Zones Post-Conflict was held under the co-chairmanship of the Minister of Humanitarian Action, Solidarity and Reconstruction in the North, France and MINUSMA**. The Ministers of Economy and Finance, of Health and Public Hygiene, of Territorial Planning and Population, and of Decentralization

**2.** MINUSMA, through the S&R Monitoring & Evaluation unit, is the co-president of the **Groupe Technique Suivi et Evaluation (GTS&E) on 2015-2019 UNDAF+**, of which last meeting took place on 12<sup>th</sup> of May. The Mission participates actively in this forum in order to support and accelerate the Group's work, which aims at producing and disseminating data and information which will allow the UN System in Mali to improve efficiency of interventions and to measure the impact of its support to the Government, in the UNDAF+ framework.

and State Reform attended, whereas other signatories (*Plateforme* and *Coordination des Mouvements de l'Azawad*) were absent. The meeting aimed at validating the *Plan d'Urgence et de Relèvement pour la Période Intérimaire* (2015-2017). Actions envisaged under this Plan include supports to displaced populations, school reopening and electrification.

## Trust Fund in support for Peace and Security in Mali

**1.** The Netherlands signed a contribution agreement for approximately **4.1 million USD to the Trust Fund**, earmarked for the development of the timely replacement of the ASIFU network (All Source Information Fusion Unit, within MINUSMA). This brings the total of contributions to 28.4 million USD out of which 16 million USD has been allocated to projects (see list on pages 7-8).

## Timbuktu

**1.** On 9<sup>th</sup> of May, **MINUSMA Regional Office in Timbuktu, through the Civil Affairs Division, handed over to the Académie d'Enseignement de Tombouctou important supplies of school furniture** comprised of 700 pupils desks, 42 teachers desks, 42 chairs and 21 mobile blackboards. Funded for 49,500 USD, this Quick Impact Project aims at encouraging schools reopening and teachers' redeployment in conflict-affected areas. Read more (in French): <http://bit.ly/245PbdU> ▼



**2.** United Nations Police in Timbuktu, UNPOL/MINUSMA, organised from 23<sup>rd</sup> to 26<sup>th</sup> of May, a mission to Goundam, Tonka and Diré, for the **inauguration of 4 infrastructures rehabilitated and built by MINUSMA via QIPs, for the benefit of Malian Security Forces in these localities.**

## Gao

**1.** Situated 60km from Ansongo, Fafa is the biggest village of the commune of Ouatagouna. **It benefitted in 2015 from a funding of 30,000 USD by MINUSMA to implement its QIP project related to gardening and perimeter fencing.** Since then, communities organized to take care of the 6 acres, provided with moto-pumps, seeds, fertilizers and a perimeter fence to protect it from animals. ## Kidal

**1.** On 12<sup>th</sup> of May, was held in Aliou Kidal neighborhood (in Kidal City) a **launch ceremony of the QIP project for "economic reintegration through livestock reconstitution in favor of 90 vulnerable households of Aliou"**, under the chairmanship of MINUSMA Kidal Head of Office and in the presence of local and traditional authorities, members of the implementing partner association EHEL DATASS, MINUSMA sections and an important local crowd. With a total budget of 40,950.30 USD, the main objective of this initiative is to reinforce resilience of 90 households of the neighborhood affected by the crisis, each receiving 5 goats (for a total of 450 animals donated). ▼



**2.** On 23<sup>rd</sup> and 24<sup>th</sup> of May, were held respective ceremonies in Kidal for the launches of projects for **"intercommunity meeting for peace return and social cohesion"** and **"rehabilitation and equipment of the Women House"**.

The first of the two ceremonies took place on 23<sup>rd</sup> of May at the Chamber of Industry and Commerce of Kidal, in the presence of the *Coordination des Chefs de fractions*, executing partner ASSAHSSAL NGO, women and youths associations and several MINUSMA sections. With a global cost of 25,700 USD and sponsored by MINUSMA Civil Affairs Division, the "intercommunity meeting for peace return and social cohesion in Kidal" QIP project aims at organizing peace caravans. These will include the participation of the highest levels of fractions chiefs, traditional and religious leaders as well as women and youths associations and civil society organizations of the Kidal region. The second ceremony was held on 24<sup>th</sup> of May in the presence of implementing partner AFORD NGO, Kidal women association and MINUSMA. The event concerns a project realized in two parts that are the rehabilitation and equipment of the Women House in Kidal. The rehabilitation is funded for approx. 100,000 USD through the Community Violence Reduction programme (CVR) administered by MINUSMA DDR Section (Disarmament-Demobilization-Reintegration). The equipment with furniture and office items is funded by a Quick Impact Project for 26,000 USD sponsored by MINUSMA Kidal Regional Office. Supporting those projects, the Mission creates for women of the region a space encouraging exchanges and capacity-building, in view of peace promotion and social cohesion actions.

## Mopti

**1.** **The QIP project for the clean-up of the Bani riverbanks and the east embankment of Mopti urban commune is currently under implementation by Actions Mopti NGO in partnership with Mopti town hall.**

For a budget amounting above 41,000 USD, this project sponsored by MINUSMA DDR Section seeks to improve the life of local communities. 2.6km of river banks will be sanitized and roughly 2000 m<sup>3</sup> of waste will be evacuated to the waste dump-site located in Sévaré via trucks provided by the Mopti urban commune. 120 temporary jobs and 50 long-term positions have already been created around the project.

## Peacebuilding Fund (PBF)

**1.** From 16<sup>th</sup> to 20<sup>th</sup> of May, the **Steering Committee of the PBF programme and UN agencies implementing projects funded through this Fund carried out a field mission in Gao and Timbuktu.** The objective was to take stock of progress of indicators and results on the ground for all PBF projects (see list on page 9), in the context of the PBF quarterly review. The delegation paid courtesy visits to both Governors, held 10 field visits and was delighted to observe very advanced implementation of projects, with more than 90% of activities realized. Main recommendations from the quarterly reviews were to reinforce communications and visibility on PBF projects and to build on current interventions which should be continued. ▼

**2.** Met in Gao and benefitting from financial support through the **joint project led by IOM and UNHCR**, Mrs. Balkissa, head of a household of 7 children including 4 orphans, suffering from multiple chronic diseases, manages two activities, in the market for the morning and in her shop the rest of the day. "This activity changed my life which was marked by precariousness because of my numerous diseases. My activity allowed me to cover family expenses in Gao. It also allowed me to have hope and live another life with daily pay thanks to my work at the shop during the day." Also empowered in the establishment of a small commercial activity, Mr. Touré "suggest[s] to the PBF project partners to continue with the funding support of vulnerable groups in view of stabilizing the northern regions of the country. The process will take a lot of time and recovery will happen slowly". Members of the mission also visited the construction site of a shed in the market of Château neighborhood in Gao.

**3.** Field visits related to the project led by **UN Women, UNFPA and MINUSMA** highlighted initiatives put in place by the women of the *Case de Paix* in Gao in partnership with GREFFA NGO and Gao regional hospital in taking care of gender-based violence victims. Mrs. Touré, President of the *Case de Paix*, described the operations of the entity created in 2013 in collaboration with UN Women: "this space accounts today for 55 women association. It is a coordination of women organizations that strongly contributes to the sensitization of political, social and community actors by using knowledge and know-how of peace, dialog and social cohesion. We work through communications and information channels like the media as well as direct interactions with religious and community leaders to ease social tensions and antagonisms." The *Case de Paix* also pursues the objective of stimulating income-generating activities and mutual cooperation among women.



"The *Case* works on gender-based violence, in particular with GREFFA NGO for which we are the focal points. The crisis triggered a lot of violence, hence women come to us as leaders in this fight. When a woman comes to consult me, we sit apart and I start by listening to her carefully. Then I redirect her to GREFFA NGO which is making psycho-social follow-up. As we know what it consists in, we want to do it in our *Case* and be helped by doctors onsite."

Mrs. Touré is not the only one who wants to build on these key assets. "We, women of the *Case*, want to go in the communes and organize sensitizations and fora, but we lack the necessary funding. Because our sisters who live there are also suffering", adds Mrs. Nouhoum, Treasurer of the *Case de Paix*.

**4.** The delegation also headed to Abaradjou neighborhood in Timbuktu in one of the 150 speed school centers put in place in the context of the education project for peacebuilding overseen by **UNICEF**. Meetings were held with the main beneficiaries of the project, children mainly of displaced and returned people, members of the School Management Committee (SMC) for the center and one of the teachers. A SMC representative described her engagement at community-level allowing returned parents and those who stayed to share a space for dialog and discussion on children education. She also highlighted difficulties such as the long distance to school for some children, the fact that some quit as well as difficult conditions for their food provision. ▼

**5.** In the "*Centre d'Ecoute d'Information, de Documentation et d'Education à la Paix et à la Réconciliation*" in Timbuktu, an important group of women and youths could meet the visiting delegation to discuss their perception of the **UNDP-UNIDO** PBF project and the impact of implemented actions. This support notably materialized in income-generating activities for displaced and returned women on the one hand, and socio-professional integration for youths through capacity-building and provision of various equipment on the other. Activities are undergone under the supervision of the *Conseil Régional de la Jeunesse de Tombouctou* in partnership with the *Centre National de Promotion du Volontariat* (CNPV). Mrs. Hamada, one of the supported women, shared her experience: "I was a refugee in Mentao camp in Burkina Faso. I am back in Timbuktu and I want to recover and stabilize next to my Malian sisters. I could benefit from training in gardening and cattle feeding. Now my life is changing little by little and I feel it with the other women involved in Timbuktu."

Financed by MINUSMA, Quick Impact Projects (QIPs) are community micro projects. These projects have a maximum cost of 50,000 USD and a maximum 6-months duration, in the areas of services and small public infrastructures rehabilitation, training and awareness-raising activities, employment and revenue creation. They must have both a quick and long lasting

effect meeting priority needs of the population and aim at building confidence towards the peace process, the Mission and its mandate. From 2013 to 2015, 109 projects were implemented (1<sup>st</sup> and 2<sup>nd</sup> years). Between 1<sup>st</sup> of July 2015 until 30<sup>th</sup> of June 2016 (3<sup>rd</sup> year), a 4 million USD budget will be dedicated to approximately 114 QIPs.

These projects will benefit mainly northern regions and will support requests from the Malian Government, international and national NGOs, international agencies and civil society. All projects are executed through local partners and businesses.

The UN Trust Fund in support of Peace and Security in Mali was created at the request of the Security Council (SC resolution 2085 (2012)). Member States can contribute earmarked and/or non-earmarked funds to the Fund, which aims to provide vital support to the Malian Defence and Security Forces (MDSF), assist the Malian Government in its efforts to ensure lasting peace and the return of State Authority and constitutional order, and support critical development and humanitarian interventions contributing to the immediate and long-term efforts by the international community to resolve the crisis in Mali.

It is supported by voluntary contributions from the following donors: Australia, Canada, Denmark, Germany, Ireland, Luxembourg, the Netherlands, Norway, Switzerland, Turkey, the United Kingdom and UN DOCO. The Fund's budget currently amounts to approximately 28.4 million USD, of which some 56.1 per cent has been attributed to projects.

**Newly approved projects**

**1. Support for the development of vegetable crops in the communities of Kidal, Essouk and Aneff:** The project foresees the development of agricultural wells, fencing (...) as well as the provision of training on best practice techniques. Funded through the Denmark contribution, the project is hoped to support the renewed uptake of economic activity. Budget: 150,243,200 CFA - approx. 258,110 USD. Implemented by ASSADEC Consortium.

**2. Support for water provision in Kidal:** The project builds on a nearly finished Community Violence Reduction (CVR) project in Kidal and foresees both the continued management, maintenance and securisation of the main water extraction site of Kidal, as well as the rehabilitation of the dam of Intikoi. This intervention will ensure that through the better preservation of rainwater during the rainy season there will be more time for the replenishment of the aquifer, thereby improving the water supply of the city. The project will be funded through the contribution of the Netherlands. Budget: 72,900,951 CFA - approx. 114,111 USD. Implemented by partner NGO ARDL.

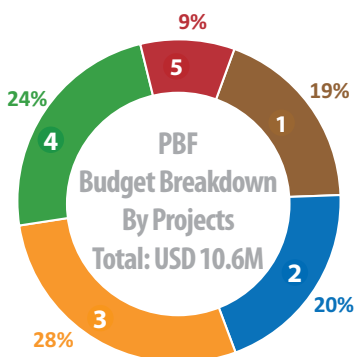

To deal with the political, institutional and security crisis that deeply destabilized Mali since 2012, the Malian Government and the United Nations System in Mali resorted to the Peacebuilding Fund (PBF) in order to support peacebuilding and reconciliation. The Government of Mali submitted an eligibility request to the Peacebuilding Support Office (PBSO) on 24<sup>th</sup> of February 2014 which was approved by Secretary-General of the United Nations on 2<sup>nd</sup> of April 2014.

In this context, the intervention of the PBF programme in Mali represents in its first phase 10.9 million USD, of which 10.6 have been attributed to 5 projects undertaken by UN agencies and MINUSMA. A Steering Committee oversees the whole programme and gathers the Malian Government, the civil society, international donors and the United Nations. The remaining 0.3 million USD goes to the Steering Committee Support Office.
