Donor Coordination and Partnerships

1. The Commission Réhabilitation des Zones Post-Conflict (CRZPC) enlarged to international NGOs met on 9th of June. Discussed subjects included the workshop on conflict-sensitive project management planned end of June and presentations of the Early Recovery Cluster and water and energy sectors in Mali. The Recovery Cluster exists at central and local level, comprised of the Government, UN System organizations, civil society organizations including NGOs, communities, leaders and donors. It contributes to the elaboration and review of the Humanitarian Needs Overview (HNO) and Response Plan (HRP), ensures that recovery interventions are in line with existing plans (HRP, UNDAF +, among others...) and aim at building institutions' and populations' resilience capacities, with a particular focus on at-risk and young populations.

Water sector is facing important challenges to cover the numerous needs of populations, in particular in the north, thus the need for better coordination between the different actors to maximize resources and reinforce water access in both urban and rural areas. In addition to tackling lack of information between actors, reflection on water infrastructures management and maintenance is crucial. In the absence of a specific approach concerning energy in post-conflict areas, the Commission advocates for a strategic reflection to facilitate better access to energy for the population. State entities in charge, like *Energie du Mali (EDM)* and the *Agence Malienne pour le Développement de l'Energie Domestique et l'Electrification Rurale (AMADER)*, provided information on energy provision in urban and semi-urban areas and on perspectives for achievements in the sector.

2. The workshop on conflict-sensitive project management was organized on 20th and 21st of June in two parts; a high-level donor conference and a capacity-building workshop. The half-day conference aimed at raising awareness on the conflict-sensitive approach and its adequacy in Mali through a combination of theory and country-specific case studies. The conference covered political and strategic issues, as well as institutional aspects to be taken into account in the use of this approach. Several Ministers, Heads of Missions and Programmes, administration and finance executives (from Bamako and the regions) were invited. The workshop followed the conference for one day and a half of in-depth learning on the application of this approach, with a focus on programmatic aspects linked to the institutional level. It covered the 'what to do,' 'how to do it' and the three steps of the conflict-sensitive project management, as well as Malian case studies.

4. On 23rd of June, the S&R-Monitoring & Evaluation Unit organized a meeting on the UNDAF+ Axis 1 «Peace and Security» so as to identify focal points and address the delays in work plan contributions from Axis 1 task force. Substantive topics to improve the UNDAF+ were agreed among various sections of the Mission and UN agencies. The discussion allowed for an open exchange on how Peace and Security issues in the UNDAF+ could be better coordinated and updated in light of recent developments at the national and regional levels, and as a result of the implementation of the peace accord.

3. A meeting with the Governors of Menaka, Taoudeni and Kidal was held on 22nd of June. The Governors appreciated the initiatives of MINUSMA and collectively indicated that expectations continue to be high amongst the local population in the regions. This is particularly the case in the area of basic social services provision. Readiness for more intensive cooperation was expressed and the importance of continued support to the three regions was underlined.

Regional stabilization plans could be considered as the road map to guide interventions and that further interactions would be required to develop specific plans that take into account the priorities and needs of the people in these regions. It was also underlined that there is a need for greater support of state technical structures to improve the delivery of peace dividends. ▼



Mopti

1. On 4th of June, in Mopti, an inauguration ceremony gathered the Ministers of Justice and Human Rights and of Health and Public Hygiene, the Mopti Governor, the Ambassador of the Netherlands, United Nations Development Programme, MINUSMA and an important crowd.

The ceremony aimed at inaugurating 4 infrastructures: a flood barrier for Mopti city with solar lightning (of a budget of 2,400,000 USD), the rehabilitated and equipped *Centre de Santé de Référence de Mopti* (on Dutch funds for approx. 1,300,000 USD), the rehabilitated and equipped Sévaré Court of Appeal and Mopti *Tribunal de Grande Instance* (by UNDP with the Ministry of Justice, for more than 420,000 USD).

In a joint effort, this ceremony was facilitated by MINUSMA, represented for the occasion by S&R OIC

Director, on behalf of the Special Representative of the Secretary-General and the Deputy Special Representative of the Secretary-General, UN Resident Coordinator and Humanitarian Coordinator in Mali.

Gao

1. On 8th of June, the QIPs for rehabilitations of the residency of the *Préfet* of Menaka and of the Menaka *Préfecture* and two adjunct housings were launched. Sponsored by the Civil Affairs Division for 73,000 USD approx., these initiatives aim at supporting the redeployment of State Authority and the operationalization of the new region of Menaka.

2. On 30th of June, a ceremony was held in Gao for the launch of 3 Trust Fund projects for the water infrastructure rehabilitation in Gao (funded through the contribution of Switzerland), in Ansongo (Canadian contribution) and in Bourem (Danish contribution). In attendance were the Deputy Special Representative of the Secretary-General, UN Resident Coordinator and Humanitarian Coordinator in Mali, a representative of the Governor of Gao region, the Regional Council President, the Danish Ambassador, the Head of Humanitarian Assistance for the Swiss Embassy, the Political Advisor for the Canadian Embassy, the Mayors of Ansongo and Bourem and the Head of MINUSMA Regional Office in Gao. Totalling over 750,000 USD, the 3 projects are implemented by a consortium of local NGOs TASSAGHT and UAVES, will generate important direct and indirect economic impacts for the region and will ensure increased production of drinking water and its distribution to approx. 100,000 beneficiaries.

2. End of June, two QIP projects were handed over in Mopti region: (1) Construction of a school with 3 classrooms, 1 storage, 1 office and 3 latrines in the Timbuktu neighbourhood of Mopti commune (sponsored by MINUSMA DDR section and amounting 41,774.14 USD); (2) Construction of a fence, 3 latrines and installation of a solar kit at the *Centre de Santé Communautaire* in Bouneoul (sponsored by the Mission's Civil Affairs Division and amounting 35,919.34 USD). While the first project's ceremony was held in presence of local authorities, beneficiaries, MINUSMA Head of Office and sections, the Mission didn't attend the second's due to security reasons.

Timbuktu

1. On 19th of June, the *Brigade Territoriale de Gendarmerie de Gossi* suffered an armed raid causing serious property damages. Fortunately, no fatality or injury occurred. This building was under rehabilitation in the context of a Quick Impact Project representing a budget of approximately 38,500 USD sponsored by MINUSMA Police.

Peacebuilding Fund (PBF)

1. Results of the first phase of PBF were presented to the United Nations Country Team (UNCT) on the 9th of June. Noting that all 5 projects were near completion in line with initial expectations, the UNCT welcomed the conclusion of the first phase. Some of the lessons learned by the PBF projects were highlighted, along with the added value of UN agencies in peacebuilding activities through enhanced integration and joint programming.

2. On 29th of June, a MINUSMA mission in Gao, led by Mr. Mohamed El-Amine Souef, Head of Regional Office, went to Fafa, Ansongo cercle, to take stock on the **construction progress of the cantonment site**. Mr. Souef was accompanied by MINUSMA DDR, Civil Affairs, UNPOL and Engineering officers. "Construction advanced really well. What's left is finishing works." declared the MINUSMA Head of Office.

Trust Fund in support for Peace and Security in Mali

1. On 22th of June, an **official handover ceremony for 2,000 solar power kits** was held in MINUSMA HQ in Bamako, in the benefits of vulnerable households in the cercles of Kidal region. Brief but highly significant, this ceremony was presided by the Special Representative of the Secretary-General and Head of MINUSMA, in the presence of several other personalities, including Kidal Governor and the Ambassador of Canada in Mali.

No less than 2000 vulnerable households, accounting for thousands of people, will benefit from the solar power kits, symbolically handed over by the Head of MINUSMA, Mr. Mahamat Saleh Annadif, in the presence of his Deputies, the Ambassador of Canada in Mali, Representatives of signatory groups, as well as Kidal region Governor and several mayors, the permanent Secretary of the National Coordination Committee for the Peace Agreement implementation (known as CNCA) and NGO Representatives. 1,100 of the kits were funded under the Trust Fund in support for Peace and Security through the contribution of Canada, whilst the remaining 900 kits were funded through QIPs. The project has a total value of approximately 300,000 USD. The kits can be put outside during the day to recharge and can then easily be used at night, providing 8-10 hours of electricity and enough for lights. They will for instance enable school-going children to do their homework after dark. The provision of the solar power kits to the population is expected to represent a real peace dividend.

2. In view of supporting the electoral administration in the organization of future elections, **several electoral storage facilities are under construction in Timbuktu, Gao, Kidal and Mopti regions**, through MINUSMA Electoral Division. These initiatives represent a global budget of approx. 700,000 USD, funded via contributions of Ireland, Canada and United Kingdom to the Trust Fund. Technical assessment missions conducted by the Electoral Division in June 2016 showed that the sites built in Douentza, Gao and Kidal cercles are nearing finalization. Storage facilities in Timbuktu, Bourem, Goundam and Niafunké cercles are also well advanced. These infrastructures come reinforcing electoral material storage and conservation capacities of local electoral administration. ▼

3. Within the support provided to justice and corrections authorities, **MINUSMA through its Justice & Corrections section (JCS) is intervening in Sévaré Prison on a project for the creation of a sheep breeding unit**. This project funded via the Denmark contribution to the Trust Fund for 44,287 USD aims at promoting the social reintegration of detainees through professional training. Operations began end of May with the building of the breeding infrastructures and include the training of 40 detainees in sheep breeding techniques. ▼

The solar kits were delivered in Bamako a few days before the ceremony. They have since arrived in Kidal and are currently being distributed in the various cercles.

Financed by MINUSMA, Quick Impact Projects (QIPs) are community micro projects. These projects have a maximum cost of 50,000 USD and a maximum 6-months duration, in the areas of services and small public infrastructures rehabilitation, training and awareness-raising activities, employment and revenue creation. They must have both a quick and long lasting

effect meeting priority needs of the population and aim at building confidence towards the peace process, the Mission and its mandate.

From 2013 to 2015, 109 projects were implemented (1st and 2nd years). Between 1st of July 2015 until 30th of June 2016 (3rd year), a 4 million USD budget will be dedicated to approximately 114 QIPs.

These projects will benefit mainly northern regions and will support requests from the Malian Government, international and national NGOs, international agencies and civil society. All projects are executed through local partners and businesses.

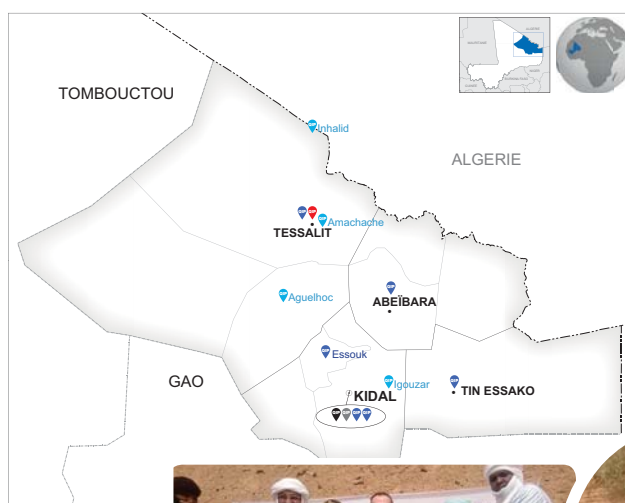

The UN Trust Fund in support of Peace and Security in Mali was created at the request of the Security Council (SC resolution 2085 (2012)). Member States can contribute earmarked and/or non-earmarked funds to the Fund, which aims to provide vital support to the Malian Defence and Security Forces (MDSF), assist the Malian Government in its efforts to ensure lasting peace and the return of State Authority and constitutional order, and support critical development and humanitarian interventions contributing to the immediate and long-term efforts by the international community to resolve the crisis in Mali.

It is supported by voluntary contributions from the following donors: Australia, Canada, Denmark, Germany, Ireland, Luxembourg, the Netherlands, Norway, Switzerland, Turkey, the United Kingdom and UN DOCO. The Fund's budget currently amounts to approximately 24.4 million USD, of which some 73.9 per cent has been attributed to projects.

Newly approved projects

1. 95 solar power street lights for Kidal: The project envisages the installation of 95 solar panel street lights in several streets and key locations in Kidal town. It also foresees the creation of local employment opportunities during the course of project implementation, community outreach activities and the provision of training of a local management committee for the maintenance of the street lights. The project is funded through the contribution of Denmark. Budget: 116,710,650 CFA - approx. 195,345 USD. Implemented by NGO ASSADDEC.

2. Rehabilitation of the Gao water drainage system: The project envisages the rehabilitation of the Gao drainage system which is broken in many places. Because the water is not properly evacuated, Gao often suffers from flooding during the rainy season, leading to loss of property and life. The lack of proper evacuation of water also leads to a situation under which water-borne diseases are able to thrive. The project is funded through the contribution of Denmark. Budget: 159,239,588 CFA - approx. 265,294 USD. Implemented by partner NGO AADIS-Mali.

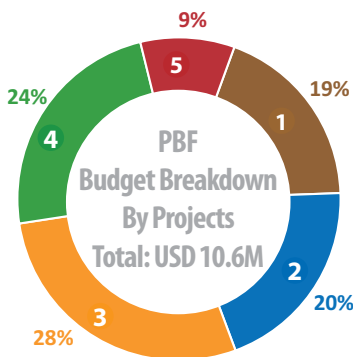
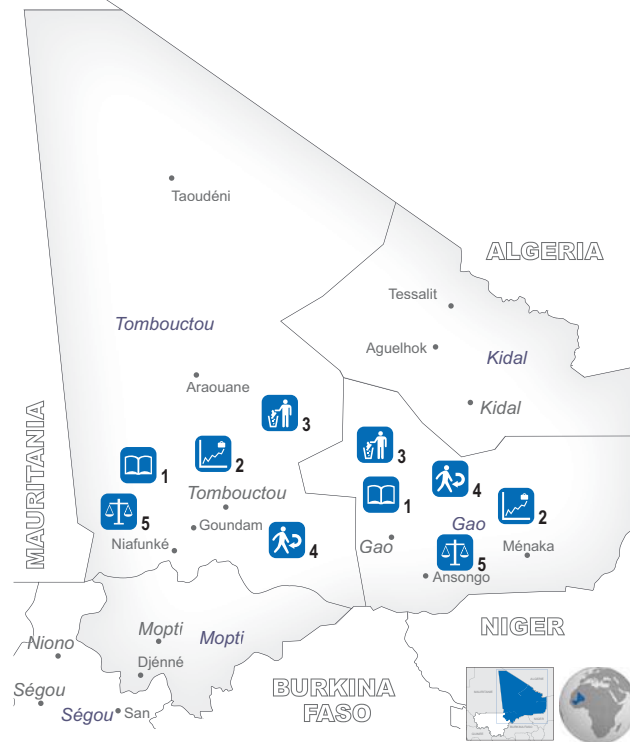

To deal with the political, institutional and security crisis that deeply destabilized Mali since 2012, the Malian Government and the United Nations System in Mali resorted to the Peacebuilding Fund (PBF) in order to support peacebuilding and reconciliation. The Government of Mali submitted an eligibility request to the Peacebuilding Support Office (PBSO) on 24th of February 2014 which was approved by Secretary-General of the United Nations on 2nd of April 2014.

In this context, the intervention of the PBF programme in Mali represents in its first phase 10.9 million USD, of which 10.6 have been attributed to 5 projects undertaken by UN agencies and MINUSMA. A Steering Committee oversees the whole programme and gathers the Malian Government, the civil society, international donors and the United Nations. The remaining 0.3 million USD goes to the Steering Committee Support Office.
